

**A regular meeting of the Village of Victor Board of Trustees was held on Monday, May 21, 2018 at the Village Hall, 60 East Main Street.**

Meeting was called to order by Mayor Hadden at 7:00pm.

**Privilege of the Floor**

**Glenn Cooke, President, Drumlins HOA**, came before the board stating the Drumlins Homeowners Assoc. met and approved the proposed resolution for dedication of some of the roads in the Drumlins with one request. Mr. Cooke asked that the HOA pay for the work needed be paid in two installments; half up front and the balance when the work is completed as opposed to paying the full amount up front.

The board agreed to that request.

**Resolution #63-18**

**Dedication of Partial Roads in Drumlins**

**WHEREAS**, a portion of the private drive known as "Wellington Drive" in the Drumlins development is located within the Village of Victor, and

**WHEREAS**, Wellington Drive was constructed as a private drive and, since it was constructed, it has been maintained by, and at the expense of the Drumlins Homeowners Association (hereafter, the "HOA");

**WHEREAS**, a number of residents of the Drumlins subdivision and the HOA have requested that the Village accept dedication of Wellington Drive and of several other private drives which intersect Wellington Drive ( hereafter, said intersecting drives shall be referred to as the "Abutting Private Drives") to the extent that they are located in the Village of Victor;

**WHEREAS**, a number of residents of the Drumlins subdivision and the HOA have, also, requested that the Village accept dedication of the improvements for storm sewers and electric lighting along Wellington Drive and along the Abutting Private Drives (hereafter, the "Utilities");

**WHEREAS**, at the request of the Village, the HOA has conducted certain subsurface tests and has performed certain work on Wellington Drive;

**WHEREAS**, the Village engineer and the Director of the Village Department Works (the "Director") have inspected Wellington Drive and reviewed the test results;

**WHEREAS**, the Village engineer and the Director have reported that the portion of Wellington Drive from where it enters the Village at the southeast corner of the Village to the northern intersection of Wellington Drive and Cambridge Circle and, also Cambridge Circle, itself, are in good condition and, provided specified work is performed on Wellington Drive and Cambridge Circle, such portion of Wellington Drive and Cambridge Circle can be maintained in a manner similar and at a comparable expense to other dedicated roads within the Village. Said portions are identified in red on a map reviewed by the Board, a copy of which shall be annexed to this Resolution;

**WHEREAS**, the specified work which must be completed on such portion of Wellington Drive is:

- Repair of all catch basins on Wellington Drive and the Abutting Private Drives,
- Replacement of the corrugated metal pipe crossing near Cambridge Circle,
- Repair of the concrete pipe outfall west of Brookline Avenue, with end-section and medium stone fill erosion controls added
- Repair of the storm manhole at number 8 Cambridge Cir.
- Street and stop signs installed;

**WHEREAS**, upon the request and at the expense of the HOA, the Village DPW will perform all of this work on a time and materials basis, the HOA will pay one half (1/2) of the estimated cost of \$5250 (\$2,625) in advance of the performance of the work and the HOA will promptly pay the balance of the actual cost upon completion of the work;

**WHEREAS**, prior to dedication, the HOA shall provide to the Village with an instrument survey map, a boundary line description, a proposed deed, recording papers, a title insurance commitment and all recording and title insurance fees for the portion of Wellington Drive to be dedicated, all of which must be satisfactory to the Village Attorney;

**WHEREAS**, the Village Board has determined that the Abutting Drives and that portion of Wellington Drive which is North of the northern intersection of Wellington Drive and Cambridge Circle were not built to dedication standards and cannot be maintained in

a similar manner and at a comparable expense to other dedicated roads in the Village of Victor and, therefore, the Village is not willing to accept dedication of that portion of Wellington Drive or of the Abutting Drives;

**WHEREAS**, the Village Board has determined that it would be appropriate for the Village to accept dedication of utility improvements along Wellington Drive and along the Abutting Drives, provided the HOA provides an instrument survey map, boundary line description, a proposed deed granting the easement, recording papers, a title insurance commitment and all recording and title insurance fees for the easement, all of which must be satisfactory to the Village attorney, Village engineer and Village Director of Public Works; and

**NOW, THEREFORE**, upon motion of Trustee Carol Commisso, seconded by Trustee Robert Kelly,

**BE IT THEREFORE RESOLVED**, provided the HOA satisfy each of the conditions set forth above within six months of the date of this resolution, the Village shall accept dedication of Wellington Drive from the Village line to the Northern intersection of Wellington Drive and Cambridge Circle, and the Village shall accept dedication of the Utilities.
