**VICTOR TOWN BOARD ISSUING POSITIVE DECLARATION RELATING TO
THE ADOPTION OF THE COMPREHENSIVE PLAN FOR THE TOWN OF
VICTOR**

On motion of Councilman Palermo, seconded by Councilman Crowley, the following resolution was

WHEREAS, the Town Board (the "Town Board") of the Town of Victor (the "Town") has identified the need to update the Comprehensive Plan as a result of the Town of Victor's growth and change since the adoption of the 1995 Comprehensive Plan; and

WHEREAS, in conjunction with the Village of Victor, the Town Board formed the Comprehensive Plan Committee and charged it with creating a new, up to date Comprehensive Plan; and

WHEREAS, with much public input and with much time and effort, the Comprehensive Plan Committee has recommended to the Town of Victor a draft Comprehensive Plan to replace the current 1995 Comprehensive Plan; and

WHEREAS, said draft Comprehensive Plan ("Comprehensive Plan") is now on file with the Victor Town Clerk where it is available for examination and review by the public; and

WHEREAS, in conjunction with development of the Comprehensive Plan, the Town has developed a draft Agricultural and Farmland Protection Plan, which is a component of the draft Comprehensive Plan; and

WHEREAS, said draft Agricultural Farmland Protection Plan is now on file with the Victor Town Clerk where it is available for examination and review by the public; and

WHEREAS, the adoption of the updated Comprehensive Plan and the adoption of the Agricultural Farmland Protection Plan together comprise a Type 1 "Action" subject to environmental review pursuant to the NY State Environmental Quality Review Act ("SEQR"); and

WHEREAS, on January 26, 2015 the Town Board was declared lead agency and began to undertake an environmental review of the Action pursuant to SEQR; and

WHEREAS, a Full Environmental Assessment Form ("EAF") was prepared for the Action; and

RESOLVED, that the Town Board hereby adopts and approves Parts 1 and 2 of the EAF; and be it further

RESOLVED, that as set forth in Part 2 of said EAF, the Town Board hereby finds that the Action may have potential significant adverse environmental impacts, including, but not limited to, the following areas:

- Open Space / Recreation,
- Transportation,
- Consistency with Community Plans, and
- Consistency with Community Character; And further

RESOLVED, that the Town Board hereby approves the attached Part 3 of the EAF, confirming its findings in Part 2 of the EAF, setting forth its basis and reasoning relating to potential adverse environmental impacts; and be it further

RESOLVED, that in accordance with said Part 3 of the EAF, the Town Board hereby issues a Positive Declaration pursuant to 6 N.Y.C.R.R. § 617.7 with respect to the Action, requiring the preparation a Draft Generic Environmental Impact Statement; and be it further

RESOLVED, that the Town Board hereby directs that the Part 3 of the EAF be filed in accordance with SEQR regulations; and be it further

RESOLVED, that the Town Supervisor is authorized to execute such necessary documents and to take such other actions as will facilitate an orderly and proper SEQR process; and be it further

RESOLVED, that copies of this resolution be sent to all involved and interested agencies.
