RESOLUTION

RESOLUTION #104 APPOINT RICHARD O'DONNELL - FINANCE DIRECTOR

On motion of Councilman Condon, seconded by Councilman Guinan, the following resolution was adopted:

5 Ayes: 0 nays (Marren, Condon, Kahovec, Guinan, Cusimano)

WHEREAS, the Town's current Finance Director, Barbara Cole, will be retiring on May 28, 2021; and

WHEREAS, the Town Board wishes to replace this position immediately in order to allow training to take place prior to Barbara Cole's retirement; and

WHEREAS, interviews were held and the interview committee selected Richard O'Donnell as having the necessary skills for the Finance Director position; now, therefore be it

RESOLVED that Richard O'Donnell be appointed to the Finance Director position for the Town beginning on April 12, 2021 at a salary of Seventy Five Thousand dollars (\$75,000.00)/year, with the salary amount to be pro-rated based on the April 12, 2021 starting date, to be charged to the 2021 Town Budget Line Item #A.1220.100 – Supervisor.Personal Services; and be it further

RESOLVED that a copy of this resolution be sent to Richard O'Donnell, Town Supervisor, Finance Department, Town Clerk, and Human Resources.

Supervisor Marren thanked the interview committee consisting of Tina Kolaczyk, Barb Cole, Peg Beaulieu, Supervisor Marren and Deputy Supervisor Dave Condon.

Councilman Condon agreed that the committee did an excellent job with questions and discussions. Rich clearly was interested in the job and had a portfolio ready. The committee felt he would be a good person to work with and he will embrace the team concept. Councilman Condon feels being a Victor resident is a huge plus when working for the town. Supervisor Marren agreed and noted many of our Victor residents work for companies that represent the Town.
